INVITATION FOR SELF-NOMINATION TO APPEAR ON THE BALLOT FOR SELECTION OF THE ADJUDICATION PANEL

Eligibility to Self-Nominate:

1. Applicants must be available to judge the Oireachtas from the start of the competitions on Sunday, 24th of March, until their services are no longer required on Sunday, 31st of March, 2024.
2. Applicants must be available to attend a pre-Oireachtas meeting on the evening of Saturday, 23rd March no earlier than 5:00pm, at a venue to be advised, plus any other meetings as requested by either the Chair of the Oireachtas Committee, the Chair of An Coimisiún le Rincí Gaelacha or the Chair of Coiste Faire.
3. Applicants must be free to judge all events on the syllabus. It is not possible to request to be left off a certain competition to permit conflicts/associations to participate. Requests for such will not be entertained.
4. Applicants must have been registered continuously as an ADCRG with An Coimisiún le Rincí Gaelacha for a minimum of two (2) years as of 18th December, 2023 to adjudicate this World Championships
5. Applicants must also have judged on a panel of three or more adjudicators for a championship event at a minimum of three (3) separate registered feiseanna.
6. Applicants must not have adjudicated an “open to all” secondary qualifying event in the 12 months prior to the Championships and may not adjudicate an “open to all” secondary qualifying event in the 12 months following the Championships.

7. Applicants who have been subject to formal disciplinary procedures may not officiate at Oireachtas Rince na Cruinne unless all relevant sanctions have concluded prior to the date of application.
8. Per the motion passed at AGM 2014 to take effect 1st January 2015, and adjudicator can only adjudicate at Oireachtas Rince na hÉireann and/or Oireachtas Rince na Cruinne once in every five (5) years. Therefore, applicants who judged either event in 2019, 2020, 2021, 2022 or 2023 are ineligible to adjudicate the 2024 World Championships.
9. The right of a dancer to compete takes precedence over the right of an applicant to self-nominate for Oireachtas Rince na Cruinne 2024. The onus is solely on the applicant to determine all direct and indirect conflicts which may impact on their eligibility to adjudicate at Oireachtas Rince na Cruinne 2024, and to notify all their associations accordingly. Proof of notification to all direct and indirect conflicts, and proof of acceptance/agreement to abstain from registering/participating must be supplied with each application. Failure to do so may result in the dismissal of an application and will result in the termination of an adjudication contract, without recourse to compensation.
10. All applicants should review the Rules of An Coimisiún (Sections: 3, 3.2, 3.3, 3.4 & all subsections contained therein) which set out specific information relating to what constitutes a conflict of interest. These rules can be accessed at www.clr.org.ie under the RULES section.
11. Applicants must declare and provide proof of, any previously-accepted invitations to adjudicate and/or officiate at grade examinations with their application. They will not be permitted to accept any further invitations.
12. Per the motion passed at AGM 2015, an adjudicator hired for Oireachtas Rince na Cruinne is allowed to adjudicate GRADE-LEVEL competitions at feiseanna in advance of the Oireachtas, but no other level of competition/assessment from 1st January 2024.
13. Applicants will not be permitted to adjudicate/officiate at any class competitions, grade examinations or championship events between 1st January, 2024 and the completion of Oireachtas Rince na Cruinne 2024. Should the adjudicator already be committed to adjudicate/officiate in any of these instances, they must terminate those agreements, or decline to apply or accept an invitation to adjudicate Oireachtas Rince na Cruinne 2024.
14. Any costs borne by the adjudicator to cancel such contracts shall be their own responsibility, and not that of An Coimisiún le Rincí Gaelacha and/or Oireachtas Rince na Cruinne 2024.

Additional Notes:

The self-nomination process shall be open from **11 December to 18 December, 2023 (until 5pm Irish time)**. No further applications will be accepted past this date/time. Please complete the online application using the link below. An acknowledgement of your application will automatically be sent to you. This confirms only receipt of your application, and does not confirm approval to appear on the ballot. Ineligible and incomplete applications will be discarded, and no attempts shall be made to seek missing information.

All CLRG registrants will be invited to vote for adjudicators. The vote will open on **20 December, 2023, for 24 hours**. Details to follow.
