The Event

Oireachtas Rince na Cruinne was first held in 1970 at the Coláiste Mhuire Auditorium in Dublin, and is delighted to return to Glasgow for the sixth time. This event is the most prestigious Irish dance competition in the world, attracting close to 4,000 competitors, plus their teachers, families and supporters.

Blending culture and tradition with cutting edge choreography and athletic prowess, dancers will compete for recognition in solo and team competitions across eight days for one of Irish dancing's most coveted titles.

The Organization

An Coimisiún le Rincí Gaelacha (CLRG) is the central organisation dedicated to the worldwide development of Irish dancing. Based in Dublin, An Coimisiún has been in existence for nearly 100 years, and has approximately 2,100 teachers spread over 33 countries around the world.



- Irish Dance schools may include the city or area of their classes but not the address or directions
- Advertisers must obtain written permission from the parent or guardian of any minors depicted
- No inappropriate photos
- All content is subject to approval by CLRG

Social Media & Print Guidelines

• In print advertisements, no last names of dancers are permitted.

Please note Screen and Social Media content may be visible to Adjudicators, therefore stricter guidelines will apply.

- No identifiable photos of currently competitive dancers
- No photos of dancers in class costume in conjunction with the school name
- No names of dancers (regardless of status)
- No photos of dancers wearing or holding any type of award

ADDITIONAL VENDOR INFORMATION

All vendors are required to provide CLRG with proof of insurance; proof of vetting (a background clearance check to work with the Vulnerable Sector for all staff and associates; a staff list for all employees who will be working on-site; a categorical list of the main products/services you will be trading; a completed registration form; payment in full. Standard Vendor packages will be awarded on a first-come-first-serve basis. Stalls will be assigned based on space availability and the chronological order of when fees and completed contracts are received. If your application cannot be fulfilled due to space constraints, a full refund will be offered.

Standard Vendor packages include the approximate size of 12' x 12' - the actual size is determined by limitations set out by the venue. Tables can be configured to individual specifications within the allotted footprint, so long as the configuration does not impede public walkways or another vendor's allocated space. *Tables will not include tablecloths*. Please bring your table coverings and/or extra coverage for storage. One electrical point and Wi-Fi will be supplied to each vendor.

No oversized backdrops or stands higher than 6' will be permitted, to ensure that all vendors have good visibility within the space. Boundaries for each booth will be outlined and all signage, display materials, and infrastructure must fit inside the lines.

Advertising placed outside of your booth area may be available at an additional cost. Any other unauthorized signage will be removed.

Delivery, storage, access times and vendor layout will be forwarded upon confirmation of all vendors.

Vendors are cautioned to staff their booths for the duration of the seven day event.
